nlike football and basketball, high school baseball games start in the middle of the afternoon, a time that is not conducive to drawing large crowds of spectators. But, large crowds are routine at Shamrock baseball games, possibly because of the quality of the school's baseball program. Or possibly a tribute to an above-average man who has overseen and built the program over the past six seasons. According to many, the job that Coach Bryan Scheurer does with his varsity Shamrock baseball team is second to none.

Bryan works with his players through the winter and early spring months, and frequently receives calls from them asking him if they can practice even more. The reason? Simply put, it's fun to play ball for Coach Scheurer.

All of that practice pays off. The Shamrock baseball team is a perennial force to be reckoned with, a team that works to excel, not only for themselves, but for their coach. They have fun with him, they learn from him, they win for him and they love and respect him—a lot.

"I knew that win or lose Coach would have fun with us or would have something fun and positive to say about our performance each day," said former player Kyle Lay. "I never had a time when I didn't want to go to a practice or a game."

"The boys thoroughly enjoy being around Bryan because of his sincere and deep love of baseball," said Jan Simon, whose son David is a Shamrock player. Her husband, Jim continued, "David has told us that if he's having a bad day, all he needs to do is go to practice and Coach will make his day better."

Bryan is a coach who truly cares about his athletes, on and off the field. "Bryan treats every player like they're the most important player on the field," said another parent, Amy Smith. "And he expects them to respect and encourage each other that same way." She continued, "Even when my boys have made mistakes and gotten chewed out, they would get a call from Bryan after the game to make sure that they knew that he still loved them."

Tyler Smith (2010) said, "Bryan is a very respectable person and coach, who makes baseball enjoyable for everyone. Even the people who weren't sure that they wanted to be on the team would love the game after a year of playing for him."

In January, Bryan received the honor of Division IV Regional Coach of the Year from the from the Michigan High School Baseball Coaches Association (MHSBCA). It was the second consecutive year (Continued on page 9)

My Journey to the Seminary

Growing up, I often thought about becoming a priest. However, because I was unsure of what others might think, I mostly kept this idea to myself. When I graduated from high school, I considered entering college seminary, but instead enrolled at Alma College, where I earned my BA in accounting in 2005.

During my years at Alma, I joined a fraternity and became

wrapped up in partying. I made little to no time for my faith or spirituality, and it really declined in those years. I still managed good grades, but when I wasn't in the classroom, chances are I was at the fraternity house or the bar.

When I graduated from college, I took a job with the Auditor General's office for the State of Michigan, a job I thoroughly enjoyed. I purchased a condo, and things really started quieting down. I would often come home from work to a silent house. When life quieted down, God began drawing me in, and speaking to me in the silence. I started going back to Mass, started praying more, especially the rosary, and I started to frequent the Sacrament of Reconciliation.

It amazes me how God waits for us, how He waits for the right moment to speak to us. Looking back, I think I purposely made my life loud and busy because I was scared of what the Lord might be asking of me. And, I think this is true for a lot of people. I really learned the importance of silence and how much we need it. We need it to make time for God, to engage God, and to form a relationship with God. In other words, we need silence for meaningful prayer.

Through discernment and talking with priests like Fr. Larry King, I decided that I should quit my job, sell my condo, and enter the seminary. I thought that If I didn't at least give it a try, I would regret it the rest of my life. I applied with the Diocese of Lansing because the majority of my family lives that way. Bishop Boyea and the Formation Board accepted my application and have sent me to study philosophy at Sacred Heart Major Seminary in Detroit, which is where I currently live. After two years of studying philosophy, God willing, I will enter the first of four years studying theology and will be ordained a priest in 2016.

Kurt Decke (1967) knew from the time he was eighteen that he wanted to be a teacher. He received an Elementary Education degree from WMU followed by a master's degree in Educational Leadership. He taught at Albion Junior High for a few years, but, left teaching to make "real money" in the construction field. However, all the while that his hands were building material objects, his heart was yearning to build young minds. Kurt listened to his heart.



n 1989 Kurt started his second teaching career at Arizo-Lna's Apache Junction Unified School District, teaching junior high science. He immediately became aware and was concerned by the fact that students who got into trouble were thrown out of school. This approach seemed to be harsh and shortsighted. "So many kids mess up at this time of their lives. Junior high experiences become an excuse for dropping out of the human race. I wanted to give them a chance to become productive adults," he said.

For three years he lobbied for a school program for those troubled kids but the best he could get was an after-school program which he ran, with rampant determination. "Until 2:00 I was a mild-mannered science teacher," he said. "At 2:00 I became Mr. Mean & Nasty while I

immediately apparent were two things: 1) Working parents had no way to transport their children to school at 2:00 in the afternoon; 2) Parents were very concerned about what their children were doing in the hours before they came to school. Grim determination caused Kurt to continue his quest for a better program.

His hard work paid off in 2002, when the Mountain Shadows Education Center opened its doors. At that time Kurt was the teacher and his assistant, Tom Hill performed registrar, secretary, nurse and counselor duties. Today, they have 20 people who work with them and they oversee six programs. A year ago, an on-line program was started for high school students for credit recovery and "fifth-year" seniors. Last year the school graduated 20 students. Twenty students who were in danger of becoming hopelessly lost were given another chance to lead productive lives.

One of the programs that Kurt is most proud of is the Young Parents Program that includes a state-licensed day care facility for the babies of the high school girls. Other districts also have day care

programs, but this one is unique. Instead of dropping their babies off at the day care center and reverting to teenage behavior during the school day, these young mothers are required to work three hours a day in the day care center. They are also required to take classes which include pre and post natal PE, child development and life skills. In addition, if their child has an issue while in day care, the mother is called out of class to deal with it. Kurt is proud of a picture that hangs in his office showing himself and Governor Janet Napolitano, who visited the school to see for herself what his program was achieving.

Other programs that Kurt has helped implement are:

• The Mountain Heights program for K-8 emotionally disabled special education kids.

• The Mountain Health and Wellness program which provides group and individual counseling and behavior modification services along with family counseling.

• The Focused Behavior Intervention program which provides early intervention for at-risk kids.

St. Patrick School Wins National Award

The March 2011 issue of *Today's Catholic Teacher* arrived in the mail on February 28, bringing along the exciting news that St. Patrick School has won a national award and is featured in the magazine along with eleven other Catholic schools that are leading the way with innovative programs.

The program which garnered national attention is our *Try Us, You'll Like Us* program that is in its second year. The program allows new families to send their children to St. Patrick School for one quarter without tuition.

The idea for this program came from School Commission member Mark Davis, who suggested that we give parents the opportunity to try our school without taking a financial risk. His thought was, that if families are able to see firsthand that we are doing a great job of providing a quality, Catholic education, they will want to stay.

With that one idea the new program was born. We implemented it in the second semester of the 2008 – 2009 school year. Since that time our enrollment has grown by seven percent.

Several other Catholic Schools have contacted me with questions about *Try Us, You'll Like Us.* Last fall, Bay Area Catholic Schools implemented the program with some special touches of their own, resulting in a modest increase in enrollment this year after two years of declining enrollment. Other schools, including one in the Diocese of Lansing are looking at using the program in the near future as well.

I am very excited that St. Pat's has received such prestigious recognition. The award will be presented at a special celebration banquet in New Orleans on April 27 which will coincide with the National Catholic Education Association's annual convention. We are thankful for and appreciative of this great honor and hope it will inspire Catholic educators everywhere to open their classrooms, schools, and imaginations to new ideas.

A MAP for Education

E lementary students are now being evaluated academically with a computer tool called a MAP (Measure of Academic Progress). The test measures a student's progress three times a year and alerts teachers and parents to areas that might need extra work, as well as areas of academic strength.

Tests are tailored to an individual's current achievement level. This gives each student a fair opportunity to show what he or she knows and can do. Because the computer adjusts the difficulty of the questions as the test progresses, each student takes a unique test. MAP testing will allow us to develop a plan for each student and then provide the tools for making sure that the student stays on course.

We've been quite impressed with what we've learned already, in the initial round of testing, and look forward to where this MAP will lead us in the future.

Much of the work on the new softball field located in the southwest corner of Father Flohe Field was completed before winter weather arrived. Several trees were removed from the grove area, the field was graded, a sprinkler system was installed, grass planted, dugouts installed (for both the baseball and softball fields) and backstops erected (baseball and softball).

Donations of materials and labor, as well as monetary donations including several memorial funds have covered all of the costs incurred so far.

Work that remains to be done includes roofs on the dugouts, fencing for the softball field and additional fencing for the out-of-play areas of both fields. Future plans include a concession area and other upgrades to the area.

Everyone involved in the project, as well as players and coaches are hopeful that the field will be ready to use for the 2011 season.

Our Faith, Our Future

s most folks who live in the Diocese of Grand Rapids know, the Diocese is currently conducting a study which will help plan the future of our diocese. Although there are several reasons for this, the primary reason is the simple fact that we do not have enough priests in our diocese to pastor all the parishes we have now. In addition, in less than ten years the majority of the priests in our diocese will be 70 years old or more. The question then becomes, who's going to run the parishes, and who's going to be available for the sacraments?

Most priests do not totally retire – they only retire from the administration of parishes. If their health allows, most priests still help out in parishes for Masses on the weekends and at other times.

So, our Diocese is planning for the future, something that several other dioceses around us have already done. As I write this column, the Ionia Deanery, which includes St. Patrick Parish, and the Muskegon Deanery are entering into this study. It will be completed by fall and a lot of work, collaboration, listening, making recommendations, not to mention a lot of prayer will go into this planning effort.

Over the next several months, there will be several meetings between the Diocesan planners and parish representatives. I asked the Pastoral Council, Finance Council, and Ministries Council in our parish to recommend people to be our parish representatives. A fairly significant list of names was given to me, and from that list I chose five men and five women, all of whom are active leaders in our parish community. All ten, who represent a good cross-section of parishioners, accepted this challenge. This group is called the Lay Leadership Committee. Each parish will have such a committee.

In addition, a Coordinating Committee which will consist of one person from each parish, one represen-


tative from each parish in the Deanery, one priest representative, the Dean (who happens to be me), and a representative of the Hispanic community, along with the Diocesan Planners will help interpret the input and implement the resulting plan.

The first meeting of the Coordinating Committee was held in Februruy here at St. Patrick's. The input gathered there will be analyzed, the two committees will bounce the ideas back and forth, refining and add-

ing to them, and the final recommendations will be made to the Bishop.

The Bishop, with the help of the Presbyteral council will make decisions based on the recommendations and input. Hopefully, all of this will be finished by fall.

The plan is to keep parishes as aware as possible about what is happening during the planning process., so that when the decisions are made and the recommendations are implemented, there won't



be any surprises. The priests of the Ionia deanery have met with the Diocesan Planners and we all agree that communications with parishioners is vitally important. We are committed to doing the best we can to make sure that communication happens.

Please keep St. Patrick Parish, the Ionia Deanery, and the Diocese of Grand Rapids in your prayers as we go through this planning process, so as to better serve the Catholics in our Diocese.

Elementary schools can refer students to this program for short periods of time. "I have always maintained that if I could get to some of these at-risk kids early, I might not see them when they get to junior high," Kurt said.

• Preparing All Students for Success, their newest program, provides special education for junior high school students who are not labeled as emotionally disabled, but have severe social difficulties in their relationships with other students and staff.

There are approximately 100 kids attending these programs on a daily basis.

Last spring budget concerns in the school district resulted in the closing of several elementary and middle schools, and the laying off of many faculty, including two principals and two assistant principals. The school district could no longer justify Kurt's position as principal when so many other administrators had been layed off. He was demoted from principal to Director. His title changed, but not his responsibilities.

While the "real money" is still made outside of teaching, Kurt feels that there is no greater reward than making a difference in others' lives. Every day he goes to the front line to fight for these kids, to give them the opportunity for a quality life and hope for a future. He is changing the world, one student at a time.

While Kurt claims to have many helping hands, his Shamrock-style determination has definitely made him the bull behind the horns in procuring the programs and facilities needed to support these special and challenged children.

Kurt is married with four children and one stepchild. In his leisure time, he enjoys reading and hiking the Superstition Mountains which are within walking distance of his home.
